

# **Terms and Conditions**

## **Reservation and Payments**

A deposit of \$100.00 is required 7 days after confirmation. The balance is payable no less than 45 days prior to departure. Payment not received in time results in penalties or higher rates.

## **The Operator Cancellations**

In the event that Vytis Tours either cancels or amends a tour, Vytis Tours shall bear no responsibility beyond the refunding of the money paid to Vytis Tours by tour participants.

## **Cancellations**

All cancellations must be made in writing and addressed to Vytis Tours. Cancellation is acknowledged for purposes of penalty assessment when Vytis Tours receives such written notice.

## **Cancellation Fees**

Cancelled - 34 Days or more prior to departure - 50%

Cancelled - 33-22 Days - 60%

Cancelled - 21-17 Days - 75%

Cancelled - 16-0 Days - no refund

## **Insurance**

We strongly recommend that you purchase luggage and accident insurance. Vytis Tours is not liable for loss, damage, or theft of personal property, or for personal injury, accident, or illness. It is important for your own protection that you have adequate insurance. Trip cancellation, health, accident, and baggage insurance are available through Vytis Tours.

## **Baggage**

## **Travel Documents**

Your U.S. Passport must be valid at least 6 months or longer after your return date of your trip. If your passport expires in less than 6 months, you should renew it prior to your departure from the U.S. U.S. citizens require a visa for Russia.
